Sub: Reminder Request for approval of Proposal for Benevolent Fund and Group Term Insurance Scheme for all willing Executives working in BSNL Maharashtra Circle.

Sir,

With reference to above subject and letter, SNEA MH has submitted proposal for Benevolent Fund and Group Term Insurance Scheme for welfare of all the willing Executives working in BSNL Maharashtra Circle. After this incident one more JTO has passed away and his family has to struggle from door to door and it would have been helping hand to the aggrieved family if timely action could have been taken and decision could have been taken on the proposal submitted by SNEA MH.

After discussions in Formal Meeting and firm assurance by your good self in the formal Meeting with SNEA MH on 19/01/2018, we have submitted the proposal on 02/02/2018 vide letter under reference. Since last two months of submission of the proposals and as per our subsequent discussions with GM Fin Mumbai, GM HR/Admn Mumbai, DGM Admn Mumbai, there is some progress in moving ahead with Group Term Insurance Scheme, but there is no progress in Benevolent Fund Scheme. We feel that there is need of more and specialized efforts in finalizing both the proposals at the earliest so that no more family of any executive in Maharashtra Circle is deprived of helping hand under this scheme in case of any unfortunate event about his/her life.

We can understand that there is need of proposals from Insurance companies in case of Group Term Insurance Scheme to have better option and to have reasonable proposal but there is no involvement of outside agencies in case of Benevolent Fund and matter needs to be taken care in BSNL office only and hence

your prompt intervention is required to give early shape to this proposal as well as proposal of group Term Insurance scheme.

Sir, we again put record, that on part of SNEA we are ready to take initiatives and pursue matter with concerned authorities and companies as and where required, but there is need for initiatives and strong proposal from BSNL with required data so that BSNL gets early response from Insurance companies and with brand name of BSNL the premium charged in this case will be less and direct benefit will go to the members of the scheme.

We fear that some junior officer in Admn section will propose in the file that we will ask guidelines from BSNL Corporate office and proposal will be kept cold storage as no response will be received from BSNL Corporate office. We have seen in many other cases that officers in Admn section are more interested in sending proposal to BSNL Corporate office, rather than talking decision and unfortunately all such action are being taken with your kind approval and the issues are unnecessarily delayed, but we cannot afford more delay in any of these proposals and hence we will request your personal intervention in the finalization of both the proposals in time bound manner.

We are confident that at least with your direct intervention both the proposals will be finalized at least by end of April 2018 and its operation starts from 1st May 2018, so that we can provide immediate financial assistance to the family in grief and by the way the entire BSNL as a family can stand in support of aggrieved family members during the period of crises and when family members are in need of such support.
