The details information as called by your office in respect of this letter is as follows.


1. I hereby confirm that complaint under reference was addressed to Shri. Peeyush Khare, CGMT MH requesting him for review the decision to opt for FTTH & Mobile connections of AirTel by surrendering all MTNL Connections in Mumbai area.
2. Self-attested copy of Pan Card AAJPA2141F is attached as my identity proof as directed by your office.

6. I am aware that a person making false complaint can be prosecuted under section 182 of India Pinal Code.
7. I am assured that the above mentioned records are required for ascertaining identity of the said complaint and shall not be used by your office doc any purpose unrelated to complaint.
8. In your email specific letter number is not given and on said date I have written three letters on different matters, out of which two are addressed to CGMT MH and one addressed to CVO BSNL. But copy of only letter No. SNEA/MH/Cir Corr/2017-2018/62 dated 24/12/2018 was handed over to your office on 28/12/2018 and hence I am confirming facts about this letter. **(Copy attached)**. If your office refers

for different letter other than this, please inform me accordingly so that I can confirm details accordingly.

It is inform that after this complaint and certain similar complaints by me, I am being harassed by the certain officers in BSNL Maharashtra Circle and also from my association by fabricated allegations on name of not following constitution, which are far away from facts. Till now, I have raised many issues and it is first time that my request to CGMT MH and its copy to GM Vigilance Mumbai are being confirmed and I am sure that required corrective action will be taken to safeguard interest of BSNL.

I put on records that due to my such time to time vigilant initiatives and efforts to being awareness about wrong actions by BSNL Maharashtra Circle management causing loss to exchequer, raising issues of concern of members of my association as responsible Circle office Bearer of recognized association in capacity of Circle Secretary SNEA Maharashtra Circle, deliberate attempts are being made to remove me from the post of Circle Secretary SNEA MH by fabricated of charges and attempts continues for last six months and even after my detail representations . As on today also deliberately created confusion continues about my right of holding post of CS SNEA MH, and issue is pending between CGMT MH & GS SNEA CHQ.
11. Apart from this since last six months, I am being harassed and tortured by Shri. Peeyush Khare CGMT MH Circle by transferring me on pick and choose basis from Mumbai to Buldhana, by stopping my salary forcefully, by illegally and forcefully expelling me from the office in which I was working, not allowing me to enter in the office, defaming my image in office and social life by making baseless allegations and even I am being forced and threatened to expel from my present residence in Staff Quarters by posting notice on doors of staff quarters and not handing over it by DAK or by post or in person as done in earlier some cases. All this mental torture and harassment is done due to my initiatives as responsible CS SNEA MH by taking up such issues by elaborating the facts in the larger interest of BSNL and its executives.

In view of above ongoing torture and pressure tactics against me by different persons from management and from my own association, I hereby request to keep this confirmation letter as confidential and desired action may be taken by your office as required in the case.
