Subject: Compliance of instructions contained in Sec 22 - RPwD Act, 2016 R/w Rule 9 - RPwD Rule, 2017 regarding maintenance of records by government establishments

Sir,

Kind attention is invited to RPwD Act, 2016 which has laid down several guidelines to be followed by every government establishment *inter alia* to enhance Skill Development & Employment Opportunities for PwDs. In this connection, attention is invited to Sec 22 [sub sections 1 & 3] of the RPwD Act, 2016 which deals with "Maintenance of records of PwDs" by Government establishments. In accordance with the said provision Rule-9 of the RPwD Rule, 2017 lays down the "form and manner of maintaining records by the establishments".

2. Accordingly all the concerned offices are requested to maintain such a "PwD Record Register" discretely to ensure compliance with the instructions contained in Sec 22 - RPwD Act, 2016 R/w Rule 9 - RPwD Rule, 2017. It is reiterated that this register shall be readily made available whenever required for inspection alongwith such information which may be required for the purpose of ascertaining whether the provisions have been complied with or not.

3. A copy of the relevant extracts viz., Sec 22 - RPwD Act, 2016 & Rule 9 - RPwD Rule, 2017 is enclosed herewith for due adherence to the instructions as contained therein. In this regard, a compliance report is to
