Subject: Submission of net requirement of Transmission Network testing equipment against faulty/scrapped units for in-house maintenance of BSNL OFC routes (Splicing Machine, OTDR, Power Meter, Light Source etc.)-regarding.

Kindly refer to above cited subject, it is submitted that CNP Cell has processed the case of procurement of test instruments & splicing machines against the requirement received from your circle.

In this regard, PF Cell, BSNL CO has pointed out that procurement against faulty units cannot be justified. If repair is possible these should be got repaired and used, else if these equipment cannot be repaired & used these should be scrapped.


It is also noted that for certain items the total quantity available is more than the number justified by norms, and yet some quantities have been proposed for procurement. This needs to be rationalized and restricted to numbers justified as per norms. The circle wise list of requirement submitted for approval for procurement is enclosed for reference as **Annexure**.

In the view of above, it is requested to kindly get repaired the faulty units and units which are beyond repair may get scrapped immediately.

Accordingly revised requirement as per format enclosed as **Annexure** may kindly be submitted to CNO Cell by 07.09.2021 for further processing the case.
