b) Terms & conditions for providing above Broadband plans:

- (i) Above DSL/Bharat Fiber BB plans shall be available only for the new customers. However, any existing BSNL landline (i.e. not having Broadband) customer can opt above plans and existing DSL BB customer can also opt Bharat Fiber plan '500GB CUL'.
- (ii) Above DSL plans '50GB CUL', '120GB CUL' shall not be available on FTTH.
- (iii) After six months, existing customers under DSL plans '50GB CUL', '120GB CUL' shall be migrated to regular Broadband plans and those who are under Bharat Fiber plan '500GB CUL', shall be migrated to '600GB CUL' plan. Customer's consent in this regard shall be taken at the time of CAF filling.
- (iv) For those customers who do not opt any regular DSL/Bharat Fiber Broadband plan at the time of CAF filling, migrate such customers (after expiry of Six months period from the date of activation of BB connection) acquired under promotional plans '50 GB' & '120 GB' to the Broadband plan '2GB CUL' & '3GB CUL' respectively.
- (v) To curb the tendency of existing Broadband customers to disconnect existing BB connection & take new BB connection through this low value BB plans route, same landline indicator shall not be allotted to such customers. The same shall be ensured by the ITPC/circles.
- 2. Above charges are exclusive of GST.
- 3. The circles shall ensure to comply with all regulatory requirements including on line reporting to TRAI and also update the circle website. Further, circle shall ensure to comply with the TRAI guideline w.r.t. number of plans.
- 4. The above instructions shall be <u>effective with immediate effect on promotional basis for a period of 90 days in all the circles (except A&N circle).</u>
