3	For Google Nest Mini/Hub	through BSNL online portal only by paying Annual/Biennial/Triennial plan subscription fees in advance (i.e. 10.5/20.5/30.5 months plan FMC (Fixed Monthly Charges) for 12/24/36 months	Eligible subscriber can subscribe to the Bundle through BSNL online portal only by paying Annual plan subscription fees in advance (i.e. 12 months plan FMC (Fixed Monthly Charges) for 13 months service) and requisite one time charges as per above Revised Para (1) & (2).

Note: The instructions for the A&N circle shall be as per present scenario.

- 3. Above Charges are exclusive of GST.
- 4. This tariff shall be applicable only for existing stock of device available with the circle(s).
- 5. The circles shall ensure to comply with all regulatory requirements including on-line reporting to TRAI and also update the circle website. Further, circles shall ensure to comply with the TRAI guideline w.r.t. number of plans.
- 6. The above instructions shall be implemented w.e.f. 16-07-2021 on promotional basis for 90 days.
