Maharashtra Circle this month has achieved **75.16**% of target with total **9019 connections**. This achievement is not at all up to the mark as compared to the previous months and our overall rank PAN India this month again has slipped to **4**th position overtaken by Karnataka Circle (9435 connections).

FTTH Closures against provisioning for this month **-Total 2330 (25.8%)** have also increased from 19.71% as compared to last month. Jalna being the highest with 177.8% closure.

Jalna SSA continues to be the bottom most in FTTH provisioning and arresting of Closures in the Circle and is instructed to submit action plan immediately to check and improve its performance.

Sindhudurg SSA is at the TOP with 152.1% provisioning and Ratnagiri -149.8%, Goa-138.2, Satara-105.9% follow behind in the order.

In this month, MH Circle has integrated **15** Bharat Air Fiber setups. Total **114** connections have been provided through Air Fiber. Total 14 SSAs have not given a single connection and should enroll at least one RBSP vendor for provisioning in non-feasible areas and increase the coverage area of BSNL FTTH. (Copy enclosed)

Ahmednagar, Yawatmal, Chandrapur, Gadchiroli and Sangli SSAs are taking efforts in provisioning FTTH connections through Air Fiber. Bharat Air Fiber RBSPs in these SSAs may be approached for business in remaining SSAs also.

I urge all BA/SSA Heads to bestow their personal attention and ensure that FTTH Teams and BBCs are monitoring each and every OLT.Inspite of a large OLT network and high FTTH demand in the circle, progress is not upto the mark. Our aim is to maximise the connections and Target for BBCs is **one connection per OLT per day**.

All SSAs are instructed to complete TIP Invoice processing for the months of May-2021 and June -2021 immediately on priority basis. Timely settlement of Partner dues is very important to improve partner's confidence and investment in BSNL.
