**Sub: Staff requirements in CN TX-West Circle in the grade of JTOs/SDEs**

Reference is made to the letter on the above captioned subject and the letter mentioned at above ref. 3, wherein this office had requested for posting of 18 Nos. of JTOs in Maharashtra region of CN TX-W (erstwhile WTR unit). 14 JTOs were required to be posted in CNTX-W Maharashtra as no JTOs are available at these locations. 4 JTOs were required for replacement against the JTOs transferred under Rule-8.

With reference to the earlier request for posting of 18 JTOs in CNTX-W Maharashtra region, MH Circle has issued posting of 12 JTO/JEs vides orders mentioned at above ref. 1 & 2. We are thankful to MH Circle for posting of JTOs and JEs in CNTX-W Circle. This office is still facing shortage of 6 JTOs.

Following changes are requested to be made in the orders issued by MH Circle.

1. The officer at Sr. No. 7, annexed at the order at ref.1, Mr. Manish Kumar, HRMS No. 200205835, may kindly be posted at Pandharpur instead of Solapur as Pandharpur is SDCA and no staff is available at Pandharpur.
2. The officials mentioned at Sr. No. 2, Mr. Ratan D. Dhabe, HRMS No. 199800913 and Sr. No. 3, Mr. Dashrath Jadhav, HRMS No. 199801843, annexed at the order at ref.2, are not graduate engineers, may kindly be replaced with JTOs or direct recruit JEs who are conversant with new technologies and handling of modern transmission equipments. Both the officials posted in CNTX-W may not serve the purpose of maintaining the vast transmission network at Ratnagiri and Dhulia as these areas are very important stations for interstate and intrastate traffic and consists of SCR and OTN terminals.
3. It is learnt that in response to the call by MH circle for posting of officers/officials to be posted in CNTX-W, two volunteers as mentioned below had also submitted their willingness for posting in CNTX-W at Panjim.
  - 1) Shreyas Pawar, HRMS No. 200801178, JTO Mobile Sangli (own cost request)- applied on 30.03.2021
  - 2) Ashish Kumar, HRMS No. 60150394, JE Transmission, Madgaon, Goa-applied on 12.05.2021One of these officers/officials may additionally be posted in addition to the present posting made by MH Circle for CNTX Goa, so that we can relieve one JTO from CNTX-W Panjim Mr. Vinod O. K. HRMS No. 200203466, who was transferred to Kerala Circle under Rule-8 vides MH Circle order No. MHCO-STFb/36(11)/4/2020-O/o GM HR-Admin/06 dated 24.08.2020.

It is requested to post the required staff at the earliest to avoid the service disruptions due to staff shortage.
