

Sub: Withdrawal of facility of SNEA, Circle Office, District branch, Mumbai.

It is observed that election of District Body of Circle Office, Mumbai was held on 15<sup>th</sup> September 2015 as per letter No. SNEA/Mumbai/2015-2016/15 dated 28/09/2015 and thereafter no communication has been received from District Association of SNEA Circle Office Mumbai for the election of new district body as per the provisions of the constitution of SNEA.


As per the SNEA constitution period of the District Body is for two years and election of district level has to be held within the scheduled time period of two years.

As per Para 14 (2) of BSNL REA rules 2014 states that "the Association shall abide by and comply with all provisions of its constitution/bye laws"

At the time of verification of membership SNEA has given an undertaking that the "provisions of BSNL (REA) Rules 2014 are acceptable to SNEA".

In view of the above the validity of present set of office bearers of SNEA of Circle Office, Mumbai is up to 14<sup>th</sup> Sept. 2017 only.

Hence all the facilities availed over and above by the office bearers of SNEA Circle Office Mumbai is hereby withdrawn/ceased from 15<sup>th</sup> September 2017.
