Circular for IXth SNEA MH Circle Conference, Jalgaon .

Dear Comrades,

As notified vide letter No. SNEA/MH/Circle Conf/2022/1 Dated 10.10.2022, the IXth Circle Conference of SNEA Maharashtra Circle is scheduled at **Hotel Kamal Paradise, Kalinka Mata Chauk, Jalgaon-425001**. The Circle Conference will be held for two days on 12th and 13th November 2022. It is proposed to start Circle Conference Proceedings with Flag hosting on 12th November 2022 sharply from 1000 Hours and to conclude it at about 1900 Hours on 13th November 2022. The detailed agenda of the Circle Conference will be made available at the venue along with other relevant documents. All are requested to plan their journey accordingly to reach in time at Jalgaon.

Our active and brave team of SNEA Jalgaon led by **Com. Chetan Jadhav**, DS Jalgaon, alongwith **Com. J.D.Chaudhary**, DP Jalgaon, **Com.Smt Seema Pimparkar**, DT Jalgaon and Team SNEA Jalgaon is on the job for grand arrangements of Conference. Jalgaon is centralized location for all Maharashtra w.r.t.road and rail transport except Kokan region.

SNEA Jalgaon has made arrangements to receive comrades attending Circle Conference from Jalgaon Railway Stations and ST Bus stand. Comrades travelling by own vehicle should reach directly to accommodation in consultation with **Chairman of Reception Committee and Accommodation Committee**.

All DS, COBs and delegate should come fully prepared for attending IXth Circle Conference at Jalgaon and specifically the District Secretaries are requested to do the needful as per below.

1. To hold District General Body Meetings before Circle Conference and elect the delegates strictly as per the provisions of the constitution of SNEA vide clause No. 9 (a) i.e. **One delegate for 15 paid members** or part thereof being not less than ten subject to a minimum of one per District/Branch. CHQ office bearers/ Circle office bearers/ CWC/ CEC Members shall be **ex-officio Delegate for circle conference sharing the voting strength of the District to which belongs. No District shall elect delegates in excess of the permissible limits.**
2. To hold District Conference/ General Body Meetings before Circle Conference to elect fresh district Office bearers for next term, if the district body has completed its tenure.
3. To email resolution pertaining to the Organizational/HR issues and agenda points for discussions duly approved in the General Body meetings of Branch/Districts to the **Com. Amit Kulkarni, ACS SNEA MH**, email id ak_hello@yahoo.co.in ,Mob No.9422296933 and Development Issues and agenda points to **Com. S.R.Bhise, Jt.Secretary South SNEA MH**,email id srbhise@gmail.com,Mob No.9422446699 latest by 5th November 2022 for consideration and inclusion in the circle Conference Schedule/Agenda.
4. It is compulsory to each and every District Secretary, Circle Office Bearers, CWC Member, CEC Member to attend the Circle Conference as we conduct Circle Conference once in three years and no excuse may be given for any reason.
5. But till any of Circle Office Bearer, District Secretary, CWC Member or CEC Member is not able to attend the Circle Conference due to any unavoidable circumstances, he should nominate any other SNEA member of that District in his/her place with prior intimation to **Com. Shailendra Solanke, CP SNEA MH**.
6. During the Circle Conference proceedings of two days, no comrade should leave venue of meeting for any reason and will have to participate in meeting with full devotion and dedication.
7. This time also facility of Special CL is **"NOT"** available as same has been withheld in view of association referendum and hence all comrades are requested to attend this Conference with personal CL/EL whatever the case may be.


8. To plan in advance by booking railway/Road tickets and make it convenient to attend IX th Circle Conference of SNEA Maharashtra at Jalgaon along with eligible delegates and make it a grand success by their active participation and involvement.
9. Please intimate arrival/departure details to **Chairman Transport and Accomodation Committee** latest by 31st October 2022, about all the delegates and observers from their District including Circle Office Bearers, CWC members.
10. Comrades, team SNEA Jalgaon is on job to make excellent arrangements of food i.e.breakfast,Tea,Lunch,Tea(Evening), Dinner and stay arrangement on 12th and 13th November 2022 .
11. Because of any reason, may be due non-availability of journey tickets on that particular date or any other personal reason, any office bearer, needs the accommodation arrangements before or after one day of the above period, it can be **made available on payment basis and individuals should intimate details to Reception Committee before 9th November 2022.**
12. All are requested to plan their journey accordingly by railway, bus or by their own vehicle and it is up to Circle Office Bearer/CWC members to decide about the class or mode of Journey by which they travel, **but in case of reimbursement from SNEA MH, same will be made as per the sleeper class railway fare for same route regardless of the expenditure made by individual on such travelling.**
13. All DS are further requested to bring along with them the information as per the format supplied.
14. Joint Secretaries are specially requested to be in touch with all the District Secretaries in their area and guide District Secretaries in collection of above information, and see that all DS are attending Circle Conference in person or if due to any genuine issue, DS is unable to attend the meeting, he can deputed suitable any District office Bearers/Comrade in his place along with all relevant information, payments and issues with prior intimation to **Com. Shailendra Solanke CP SNEA MH.**
15. All eligible delegates will have to pay **Rs.1000** each as delegate fee.This year we have not increased the delegate fee because of financial burden on our comrades due to visit of then CGMT MH at various SSA/BA and Spandan 2022 program at Circle office ,Mumbai.
16. The constitution of SNEA doesn't permit any observer for Circle Conference as it increases expenditure on lodging and boarding. Hence no observers will be normally allowed except written and prior permission from Circle President Com. **Shailendra**

Solanke and all such permitted observers will have to pay Rs. 1500 each as observer fee.

17. It may please be noted that observers can attend meeting with such permission but they are not allowed to take part in discussions or submit their views directly in Circle Conference and same can be submitted through DS concerned or delegates from their SSA.
18. In recent past it is seen that some of DS are not paying observer fee but bringing observers with them without prior intimation and **this time observers will be permitted and provided accommodation only and only after Observer fee is paid by DS concerned.**
