
Kindly refer to this office of even letter dated 26.03.2019 (copy enclosed) wherein, Nodal Circles was requested to process the invoices of M/s Hungama till February 2019, in order to reflect the actual liability in ERP so that funds can be arranged accordingly and compliance report was requested within 7 days from date of the issue of this letter along with the fund requisition sent to BFCI, Corporate office, but compliance is still not received from any of the Nodal Circle.

Now, M/s Hungama has submitted proof of claim under Regulation 7 of the Insolvency and Bankruptcy Board of India (Insolvency Resolution Process for Corporate persons) Regulation, 2016. It has been conveyed that an outstanding claim amount of Rs. 22,14,73,245/- (excluding the interest amount accumulated) for the period from April,2010 to February,2019 is pending towards BSNL.

It is pertinent to mention that , this office has already made various correspondances with the Nodal circes & convened meetings for settlement of revenue share.

In view of the above, it is again requested to take necessary action in this regard at the earliest under intimation to this office please.


