ORDER

Subject :- Regular Promotion and posting of the Executive in the grade of AGM/DE of Telecom Operation Stream in the IDA scale of Pay of Rs.29100-54500/- reg

In pursuance of BSNL Corporate Office , New Delhi Office order **No 412-03/2017-Pers.I dated 04th July 2018** and as per approval of the competent authority, **32 Nos** of executives of Maharashtra Circle are promoted as per **Annexure-I** (Enclosed) in the grade of AGM/DE in Telecom Operation Stream in the IDA scale of pay of RS 29100-54500/- on regular basis notionally **w.e.f. 29.6.2018** at par with their juniors and on actual basis w.e.f the date the executives assumes the charge of the higher post.

- No officer has resigned/taken VR/ retired/expired on the date of issue of the order.
- Officers have fulfilled the prescribed eligibility as per the relevant RRs..

However in case of any discrepancy observed may be immediately brought to the notice of this office.

3. The charge reports submitted by the executives in pursuance of aforesaid promotion order may be sent to all concerned and entries be made in HRMS/ERP/Service Book.
4. The Executives will have to successfully complete mandatory training in 'on line mode' within two years of this order as prescribed in EPP and clarification issued from time to time for drawing second increment as per applicable rule of EPP.
5. The promoted Executives are required to join their promotion assignment immediately by before **13.8.2018** positively.
6. In case the officer concerned fails to join the promotional assignment within the prescribed period, he/she should not be relieved to join the post thereafter. In such situation, the promotion order shall become inoperative and such cases shall be reported to this office. Further, no request for modification of posting order shall accordingly be entertained.
7. The officers who have not been relieved from their earlier place of posting to join at the already posted station, they may assume the charge at the earlier place of posting or at the already posted station after being relived from earlier posted station. However this does not amount to any cancellation/modification of the earlier orders.
