And you also raised the objection for involving TWWO in the said function. clarified by GM (HR/Admn) that the proposed function involves calling various awardees which included Vishist Sanchar Seva Padak, award for outstanding performance in vertical heads of Maharashtra Circle Office and award for outstanding contribution in various Welfare Association including SEWA, Sports and Cultural Board and Welfare Association, Telecom Women Welfare Organisation and Award for maintaining cleanliness on the pretext of Swach Hi Seva Pakhwada.

Further, you outrightly rejected the format of the proposed function and raised objection in the involvement of TWWO in any manner and adamantly stated that "Management can go ahead the way it wants but his stand remains the same" as stated in the said letter. It was informed that TWWO is recognised Organisation under Ministry of telecom and women employees and spouse of other BSNL employees can be its members. When GM(HR/Admn) tried to explain and convince you including other signatories present in the chamber, you raised your voice and did not agree to listen to the words of GM (HR/Admn)and behaved adamantly and arrogantly. Even on the request of the other Unions Associations signatories, you did not listen to the request of GM (HR/Admn) and went on raising your voice in presence of undersigned. Under such circumstances, there was no option left but to request you to go out of the chamber as the other members were ready to listen to the submissions of the Management.

Your this adamant, arrognat and uncalled behaviour with Senior Management is subversive of discipline and unbecoming of an officer. You are directed to furnish to this office your reply within 5 days of receipt of this letter failing which action as per the provisions of BSNL CDA Rules 2006 will be taken.
