Sub: Identification of Utilities along the proposed Mumbai-Pune-Hyderabad High Speed

(MHHSR) Corridor.

National High Speed Rail Corporation Limited (NHSRCL), a Government of India undertaking has been formed with an object to construct, maintain, and manage the High Speed Rail Corridors in India. NHSRCL is currently implementing 508km long Mumbai-Ahmedabad High Speed Railway (MAHSR) corridor.

Railway Board (Ministry of Railways) has entrusted NHSRCL the task of preparation of Detailed Project Report (DPR) for seven more identified High Speed Corridors including Mumbai-Pune-Hyderabad High Speed Rail (MHHSR) Corridor.

The proposed Mumbai-Pune-Hyderabad Corridor (approximately 676km long) shall be elevated (on viaduct) and primarily along the major expressways and highways. The main line corridor follows cities like Navi-Mumbai, Lonavala, Pune, Solapur, Kala-Buragai, Zaheerabad and Hyderabad. Locations of stations are not yet decided. A preliminary and tentative route plan which being studied is enclosed herewith for your ready reference.

NHSRCL is in the process of finalizing an agency for undertaking detailed survey on the proposed MHHSR corridor to ascertain the quantum of utilities likely to infringe the proposed MHHSR at the time of construction. The survey is scheduled to commence from December 2020 and required to be completed in a time bound manner to pave the way for finalization of DPR.

It is to note that vide letter under reference above, NHSRCL had already requested your good office for nomination of nodal officer for Mumbai-Nagpur High Speed Rail (MNHSR) Corridor. Therefore, it is requested to nominate same (Nodal Officer of MNHSR) or separate nodal officer for NHSRCL's Mumbai-Pune-Hyderabad High Speed Rail (MHHSR) Corridor.

be highly appreciated.
