Sub: Gradation list of JAOs of DR 2015 batch- Furnishing of data on priority Basis

Ref: This office letter No. BSNLCO-PRII/11(24)/28/2021-PERS-II dated 05.07.2021 and subsequent reminder dated 27.08.2021

Kindly refer to this office letter dated 05.07.2021 cited under reference above vide which a Provisional All India Gradation /Seniority List No. 5 in respect of Junior Accounts Officers of BSNL of DR-JAOs 2015 batch was circulated with the request to check and verify the details of the candidates pertaining to your circle and intimate errors/omissions/objections etc. in the said list and furnish necessary certificate as detailed in the said letter. Subsequent reminder letter in the matter was issued on 27.08.2021.

It is seen that the requisite information has not been furnished by some of the circles although the same was required to be furnished by 31.07.2021 which was subsequently extended upto 09.09.2021. In respect of the data/ information /certificate received from the circles, the following observations are made:

1. Some of the circles have furnished data only in respect of those working in their circle at present, and have not furnished the data in respect of such DR-JAOs of 2015 batch who were recruited by the circle and who have subsequently resigned/expired/proceeded on temporary transfer to other Circles/posted in non-territorial etc.

The circles are requested to furnish the data in respect of all the DR-JAOs of 2015 batch who were originally recruited from their circle, irrespective of whether the JAOs are presently working in their circle or not.

2. Some of the columns in the provisional gradation list circulated by this office vide letter dated 05.07.2021 was left blank due to absence of data and hence, the circles were requested to furnish the requisite information which were not available in this office. However, the circles have not furnished the information of the blank columns. Also it is observed that many circles have furnished incorrect information which is posing a huge problem in the finalization of the Seniority List.

The circles are therefore requested to scrupulously verify the data forwarded by this office with their records and furnish complete and correct information. Any information/data, if found incorrect on a later date, may lead to unnecessary complications and hence accuracy in the data furnished to this office may be ensured.

3. The confirmation status of the DR-JAOs of 2015 batch has not been furnished by most of the circles.

The circles are requested to furnish the confirmation status of all the DR-JAOs of 2015 batch borne on their cadre, including those who have subsequently resigned/expired/proceeded on temporary transfer to other Circles/posted in non-territorial etc.

4. It was also requested to furnish a certificate as given below:

"All the omissions/objections/errors etc. have been incorporated in the Gradation List No. 5 of JAO DR batch-2015 pertaining toCircle and intimated to Personnel.II Cell vide letter No..... datedafter due verification from service records."

Some of the circles have furnished the said certificate, however incorrect data has been furnished.

The circles are therefore requested to furnish the above certificate/revised certificate after checking and furnishing data of all DR-JAOs of 2015 batch recruited from their circle (including such candidates who have subsequently resigned/expired/proceeded on temporary transfer to other Circles/posted in non-territorial etc.).
