Dear Shri \_\_\_\_\_,

With regard to the BSNL VRS-2019, BSNL Corporate Office has been emphasizing the need to conclude the pending activities. However, circles have not adhered to the timelines for completion of VRS related activities. As a result, Ex-Gratia amount is still not finalised in respect of many retirees.

2. As already specified in para 3(iii) of my last letter dated 15.10.2020, in cases of mismatch in service particulars e.g. LPD, length of qualifying service which require correction at the end of CCA, Annexure-D may be got verified from CCA for finalisation of Ex-Gratia amount. In this regard, DOT vide letter No. 15-37/2020-21-BA&IT/958-985 dated 23.10.2020 (copy enclosed) has already directed all CCAs to carry out verification of correctness of Ex-Gratia amount as submitted in Annexure- B & D by BSNL.

3. Further, ERP process for release of fourth and final instalment of Ex-Gratia have been issued on 28.10.2020. However, it is seen that large number of cases have not been initiated in ERP / SAP. Latest ERP report is enclosed as Annexure.

4. In view of above, all circles must ensure the completion of pending activities related to VRS optees latest by 05.12.2020 viz. Updation / correction in ERP data as per PPO data, pending cases, if any, for grant of time bound financial upgradation under EPP / NEPP, verification of Annexure-D by respective CCA in cases requiring correction in PPO(s) and initiation / verification of final Sanction in ERP/ SAP. No further extension of timelines will be allowed and the concerned erring officials will be held personally responsible.

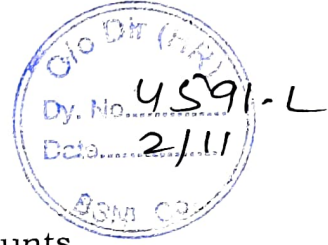

Kind attention is invited to this office letter No. 15-24/BA&IT/2019-20 dated 10.09.2020 and DO letter no. 15-37/2020-21/BA&IT/650 dated 17.09.2020 on the subject cited above. It has been brought to notice of this office by the BSNL Corporate Office that during the exercise of updating the service particulars of VRS optees as per PPO data, instances have come to notice that require updation/correction in PPOs by the respective CCA offices.

2. Further, DoT HQ vide their letter no: 1/VRS/BSNL/2019/Accounts/ TA-I/2627 dated 15.10.2020 (**copy enclosed**) has directed that :-

(i) MTNL and BSNL should be asked to submit detailed calculation of Ex-Gratia in Annexure B and Annexure D (As per SOP dated 16.01.2020) (with information from col.1 to col. 28 of Annexure D being mandatory) to CCA office, if not submitted already.

(ii) On receipt of above, CCA offices should verify the amount based on PPO Authority and as per SOP and finalize the gross Ex-Gratia amount payment to the retirees, following information may be provided to this office in Annexure -III:-

For cases requiring correction, after undertaking the correction, the amount should be finalized by O/o. CCA in close coordination with BSNL / MTNL.

3. Therefore, it is requested to carry out verification of correctness of Exgratia amount as detailed in Annexure B and D received from BSNL/MTNL, as per procedures laid down in Para 3 (A) & (B) of SOP dated 16.01.2020. In case of difference/omission found after verification of above data, the same must be communicated to BSNL/MTNL for reexamination and rectification of errors and reconciliation of Ex Gratia amount.

4. Further, it is also requested that a report in format (Annexure III) above may also be furnished along with weekly report from the week ending 23.10.2020 onwards for onward submission to DoT HQ.
