You are aware that Circle management withdrawn the facilities of Shri M S Adasul vide letter No. CGMT/MH/Admn-1/SNEA[I]/2018-19/Part File/36 dated 17/10/2018 for non-adherence/ violation of provisions of SNEA constitution and BSNL REA Rules 2014. General Secretary of SNEA CHQ New Delhi also confirmed that Shri M S Adasul violated the provision of SNEA constitution.

Further, issue of Co-option for the post of CP and CS SNEA MH Circle has not yet approved/ recognized by the competent authority of BSNL.


Your kind attention is invited to this office letter of even No. /67 dated 5/3/2019 , under which some information has been sought from you , which is not yet received to this office.
