Sub: Taking over the charge of Circle Secretary and Circle President of SNEA, Maharashtra (MH) Circle as Com M S Adasul and Com Bharat Sonawane forfeited the right to hold the post of Circle Secretary and Circle President respectively:

In the Circle Conference of SNEA, Maharashtra Circle held at Nagpur on 18-19, September 2017, Com M S Adasul and Com Bharat Sonawane were elected as the Circle Secretary and Circle President of SNEA, Maharashtra Circle respectively. On the day of Circle Conference, Com M S Adasul was holding the post of Dy General Secretary of SNEA, CHQ and Com Bharat Sonawane was holding the post of SSA Secretary, Pune SSA, Maharashtra Circle.

It is intimated by the CHQ President that a back dated resignation letter of Com M S Adasul, dated 17.12.2017 from the post of Dy General Secretary of SNEA, CHQ was handed over to him at Jalgoan, Maharashtra on 13.10.2018 by Com M S Adasul, establishing that he was holding both the posts. One copy of the same resignation letter was handed over to the General Secretary also on the same day, 13.10.2018.

It is found that Com Bharat Sonawane as SSA Secretary issued the notice for holding the SSA Conference of Pune SSA on 19.09.2018. By the conduction of the SSA Conference on 07.10.2018 as SSA Secretary, it was established that he didn't resign from the post of SSA Secretary or Circle President till that date.

Com M S Adasul and Com Bharat Sonawane failed to tender their resignation from any one of the elected posts, within the stipulated period of 3 months. Accordingly, as per the provisions of the constitution of SNEA, clause 3 (c) ii), Com M S Adasul and Com Bharat Sonawane, forfeited the right to hold both the posts they were holding, on completion of 3 months from the date of their election as office bearers of MH Circle.

In the absence of Circle President and Circle Secretary, for the functioning of SNEA Maharashtra Circle, Com Pramodkumar C Ramteke, Circle Vice President shall take over the charge of Circle President and M N Kotambe, Asst Circle Secretary shall take over the charge of Circle Secretary immediately, till these posts are filled as per the provisions of the constitution under clause 9 (e) vii), with intimation to CHQ. Compliance may be given within 15 days.
