1. Fund Management module for OPEX budget has been implemented in SAP ERP w.e.f. 25.07.2019. OPEX budget is currently given against a set of predefined heads of expenditure (i.e. Vehicle, Rent, House Keeping etc.). These are defined as "Commitment" in this guideline. The Fund Management module helps to restrict commitment/liabilities to budgeted amount and also helps to monitor operational expenses in better way. At this stage, to help the circles adapt the module faster only warning messages have been implemented in most of the commitment items and error messages (thereby meaning restriction to proceed) has been implemented only in few commitment items namely Medical, TA & LTC. The restrictions will be fully implemented in next few weeks. List of commitments and GL mapping with commitment are given in Annexure - 1 & 2.

- (b) There are few commitments related to Salary is under exempt category so that payroll process should not get hampered but Salary commitment will also be moved in error category shortly.
- (c) All open PO/PR related to OPEX & Inventory has to be short closed from the date budget availability activated on all commitment items.
