With reference to letter cited above, the approval of the Competent Authority is hereby conveyed for the transfer of Junior Accounts Officers at Annexure-I to other Circles for a period of one year on Temporary basis on the below mentioned terms and conditions as stipulated under Rule 9 at BSNL transfer policy communicated and vide letter No. 6-1/2007 – Restg dated 7/5/2008.

TERMS AND CONDITIONS

1. The transfer is at their own cost/request.
2. No deputation duty allowance is admissible to the officers.
3. No TA/DA is admissible to the officers.
4. They will have no claim for regular absorption/promotion in the new unit to which they have been deputed on temporary transfer.
5. The employees will continue to maintain their lien in their parent circle.


It may be ensured that no vigilance/disciplinary case is either pending or being contemplated against the officers. The pay and allowance of the officers will be drawn by the unit where they join on transfer.

The officers on completion of their tenure of temporary transfer may apply for regularization of transfer, if required, through the concerned circle as per BSNL Transfer Policy and C.O. letter No. 4-14/2004-SEA dated 05.10.2012.

The officers may be relieved on 30.06.2019 (A/N) or on completion of Audit whichever is later.

Further, it may be ensured that the officers may hand over the proper charge to other JAOs in their unit/ section before relieving them.

Necessary Charge report may be sent to all concerned including CAO (FC).
