The appointing authority however, reserve the right of termination of service of the appointee forthwith or before the expiration of the stipulated period of notice, by making payment to him a sum equivalent to the pay and allowances for the un expired period or portion thereof.


4. The conditions of service will be governed by the relevant rules and orders in force from time to time. This order is issued subject to revision, alternation at any time without notice.

5. Appointee is expected to serve in the unit of recruitment as long as he/she remain in the same scale or grade to which he/she is appointed and the request for transfer to other unit will not be entertained.

If any declaration is given or information furnished by the appointee proves to be incorrect or found to be wilfully suppressed the appointment is liable to be terminated in addition to any other action as BSNL may deem necessary and in case of failure to comply with any of the recruitment formalities.
