Subject: Provisioning of FTTH connections over BharatNet

Number of communications has been received in this office regarding procedures, rates and tariff for services to be provided using BharatNet. It has also been informed by Circles that due to low demand of FTTH commercial connections in rural areas it is commercially un-viable for BSNL to provide these connections.

In this regard it is informed that the revenue share agreement between BSNL and BBNL had expired from 01.07.2019 and now BSNL intends to enter into Fiber Leasing agreement with BBNL w.e.f 01.07.2019, therefore BSNL will get the lease charges for the network extended to BBNL from Block head quarter to FPOI. At the same time BBNL will charge BSNL for the network elements used by the later to extend telecom services to end user as per tariff defined by BBNL and endorsed by this office letter of even no. dated 03.10.2019. Also the procedure for creation of services in this changed scenario has been defined by BBNL and endorsed by this office letter no. 51-47/2016/NOFN/Ops, dated 21.01.2020, which is to be followed by BSNL field units.

Considering these aspects, Circles are requested to make efforts to utilize BharatNet to the greatest extent possible looking into techno commercial feasibility to BSNL.

- (1) Reason for not sharing the revenue for the period from 2019-20 to 2020-21 (up to September 2020).
- (2) Whether the agreement of revenue sharing with BBNL has expired or it has been further extended by the BSNL with the mutual consent of the BBNL. If so, a copy of the same may be furnished.
- (3) If revenue sharing agreement with the BBNL has not been renewed, then what methodology has been adopted by the BSNL for billing of BB/FTTH connection using BharatNet Phase-1 Project.
- (4) Reason for passed on the revenue on provisional basis to BBNL or not shared the revenue on actual basis.

Clarification from the corporate office is required to that queries raised by P&T audit can be resolved.
