In the recent transfer order under reference by corporate office, many executives including lady officers are unnecessary transferred /dislocated from one state to another on the name of longest stay and who has completed 26 years of service. From where this 26 years formula is calculated by corporate office, God only knows. As per transfer policy approved by corporate office the officers are eligible for interstate transfers who has completed 18 years of service. Here also there is violation of transfer policy and harassment to executives of BSNL.

Many officers are submitted their request for retention and change of station on ground of medical, spouse, ward education and association immunity. The representations are reached to circle administration through proper channels too.

It is requested to consider the representations as above positively and forward the same to corporate office with due recommendation and give justice to affected officers of BSNL Maharashtra. They will be highly obliged forever of yours.
