The issue of mismatch of service particulars, viz. Last pay drawn, lenthg of qualifying service, date of joining & date of birth, in PPO and BSNL ERP data has been brought to the notice of circles/units from time to time. This mismatch will result in discrepancy in calculation of Ex-gratia amount payable in respect of retirees under BSNL VRS- 2019. In this regard, BSNL circles/units were requested to resolve the discrepancies in coordination with respective CCAs and update the ERP data accordingly. ERP report regarding difference in Last pay drawn in PPO data and ERP data as on 14.10.2020 is enclosed for reference.

Further, grant time bound financial upgradations under EPP / NEPP to the VRS optees has also not been completed by most of the circles. Delay in this exercise may result in discrepancies in future.

Accordingly, the following actions may be taken immediately -
