- 3. He is informed that an inquiry will be held only in respect of those articles of charge as are not admitted. He should therefore specifically admit or deny each article of charge.
- 4. Shri AnilKumar Dubey is further informed that if he does not submit his written statement of defence on or before the date specified in Para 2 above, or does not appear on or before the inquiry authority or otherwise fails or refuses to comply with the provisions of Rule 36 of BSNL CDA Rule 2006 or the orders/directions issued in pursuance of the said rule, the inquiry authority may hold the inquiry against him *ex-parte*.
- 5 Attention of Shri AnilKumar Dubey is invited to Rule 22 of BSNL CDA Rules 2006 under which no employee shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service in the company. If any representation is received on his behalf from another person in respect of any matter dealt with in these proceedings it will be presumed that Shri AnilKumar Dubey is aware of such representation and that it has been made at his instance and action will be taken against him for violation of Rule 22 of BSNL CDA Rules 2006.

6. The receipt of the memorandum should be acknowledged.

The said Shri AnilKumar Dubey held responsible for submitting false / incorrect information claiming that he is District Secretary, of SNEA Mumbai and there by eligible for immunity against his transfer.

#### Article -II

The said Shri AnilKumar Dubey held responsible for his unprovoked adamant, arrogant and uncalled for behaviour with Senior Management during the discussion, meeting invited on 29/09/2018 in the chamber of GM (HR/Admn)in the presences of DGM (Admn).

#### **Article-III**

The said Shri AnilKumare Dubey held responsible for humiliating, insulting and outraging the dignity of women by opposing in writing through a representation in respect of the distribution of certificates for TWWO members along with award distribution on BSNL foundation day function dated 1/10/2018.

By aforesaid acts, Shri AnilKumar Dubey, had committed grave misconduct, failed to maintain absolute Integrity, Discipline and Decorum of office and acted in a manner unbecoming of BSNL employee thereby contravening the provision contained in rule 4 (a), (c), (d) and (e) and rule 5 (10), (12), (20), (23), (25), (31) and (35) of BSNL CDA Rules 2006.

<u>Statement of Imputation of misconduct or misbehaviour in Support of Article of Charge framed against Shri AnilKumar Dubey, SDE (NWP-CM) HRMS No. 200306190, O/o CGMT, MH Circle, Mumbai 400 054.</u>

#### Article-I

The said Shri AnilKumar Dubey had been transferred to Kalyan SSA on long stay basis vide order No. A/STB/AE-20/SDE/JTO/REQUEST TFR/2018/15 dated 31/03/2018. Shri AnilKumar Dubey requested for retention in Mumbai on the basis of immunity from transfer as District Secretary, SNEA Mumbai vide his letter dated 22/06/2018. Circle Secretary SNEA Maharashtra Circle vide letter No. SNEA/MH/Cir Corr/2017-2019/32 dated 22/06/2018 also requested to grant immunity as requested by individual office bearer of SNEA.

District Secretary, SNEA (I), Mumbai CO vide letter No. SNEA/Mumbai/2015-2016/15 dated 28/09/2015 intimated the details of elected office bearers of SNEA(I) Circle Office, Mumbai subsequent to election held on 15/9/2015, wherein Shri AnilKumar Dubey was elected as District Secretary. However no intimation has been received by the Administration about the election of District Body, SNEA(I), Mumbai after expiry of tenure of the said elected body.

As per SNEA Constitution clause No. 3 (g) (ii), which states that , 'The election at District / Division / Branch organisational level shall be held within the scheduled time period and in no case it shall be delayed from scheduled date. In case of Circle Organisations, for genuine difficulties permission may be sought for from the CHQ to have further extension for a limited period not exceeding nine months.'

As per the provision of SNEA Constitution, no intimation has been received to the administration about the election of office bearers of District Body of SNEA(I), Mumbai within the scheduled time period. In the absence of any intimation about the election of District Body of SNEA(I), Mumbai to the administration , the claim made by Shri AnilKumar Dubey as a District Secretary is false and cannot be accepted.

The said Shri AnilKumar Dubey has supressed the fact and provided the false information to the administration. The said Shri AnilKumar Dubey continued to fraudulently act as DS of SNEA(I), Mumbai and availed the immunity from his transfer to Kayan SSA. The retention order was issued by HR Section vide order No. A/STB/AE-20/IMMUNITY/2018-18/LOOSE/34 dated 25/06/2018.

#### Article-II

All Union And Associations of BSNL (BSNLEU, NFTE, SNEA, AIBSNLEA, ), Maharashtra Circle Mumbai has given representation to GM (HR/Admn) O/o CGMT, MH Circle vide letter No. AUAB/MH CIRCLE/03 dated 28/09/2018 in reference to DGM(Admin) order dated 22/09/2018 in respect of BSNL Formation day and Vishitha Sanchar Sewa Padak Award distribution function on 1/10/2018 at Circle Office Mumbai . In the said letter signatories stated that the function is to be organised in inexpensive manner and mixing of TWWO program with Sanchar Award distribution is not correct and not ethical and should be stopped. In the said letter it is also mentioned that mixing of TWWO certificate distribution or any other program with prestigious Sanchar Award there by degrades the importance of the Sanchar Awards. The last paragraph of the said letter implies the threat of boycotting this prestigious function of BSNL.

To discuss the matter , and to clarify the modalities of the function , all four signatories including said Shri AnilKumar Dubey were invited in the chamber of GM (HR/Admn) in the presence of Shri R.C.Chavan, DGM (Admn) . During the meeting , when GM(HR/Admn) started to explain the facts related to the representation dated 28/09/2018 , the said Shri AnilKumar Dubey raised the objection regarding the arrangement and modality of the proposed BSNL Day and Vishist Sanchar Sewa Padak award distribution function on the issue of expenditure of lakhs of rupees . Shri AnilKumar Dubey also raised the objection for involving TWWO in the said function. GM (HR/Admn) tried to explain that the anticipated expenditure for the proposed function was not exorbitant and within the rules of BSNL .However said Shri AnilKumar Dubey adamantly stated that, "Management can go ahead the way it wants but his stand remains the same . When GM(HR/Admn) tried to explain and convince Shri AnilKumar Dubey, he raised his voice and deed not agree to listen to GM(HR/Admn) and behaved adamantly and arrogantly . Even on the request of the other unions and associations signatories, Shri AnilKumar Dubey did not listen to request of GM(HR/Admn) and went on raising his voice in presence of Shri R.C.Chavan, DGM(Admn). This adamant , arrogant and uncalled for behaviour of Shri AnilKumar Dubey with Senior Management is subversive of discipline and unbecoming of an officer.

#### **Article-III**

All Union And Associations of BSNL (BSNLEU, NFTE, SNEA, AIBSNLEA), Maharashtra Circle Mumbai has given representation to GM (HR/Admn) O/o CGMT, MH Circle vide letter No. AUAB/MH CIRCLE/03 dated 28/09/2018 in reference to DGM(Admin) order dated 22/09/2018 in respect of BSNL Formation day and Vishitha Sanchar Sewa Padak Award distribution function on 1/10/2018 at Circle Office Mumbai . In the said letter signatories stated that the function is to be organised in inexpensive manner and mixing of TWWO program with Sanchar Award distribution is not correct and ethical and should be stopped. The signatories further stated that, 'not to mix TWWO Certificate distribution or any other program with prestigious Sanchar Award distribution function and maintain prestige of this awards and BSNL day celebration .'

Telecom Women's Welfare Organisation (TWWO Mumbai MH under the aegis of – TWCO, New Delhi ) is a permanent organised welfare organisation of Department of Telecom, Ministry of Information Technology and Communication , Government of India. The main objective of the organisation is promotion of the welfare of the families of the employees. All Telecom Circles of BSNL have similar women's organisation known as Telecom Women's Welfare Organisation (TWWOs).

The letter dated 28/09/2018 has been signed by said Shri AnilKumar Dubey and not only signed but also argued indecently justifying his act in\_spite of efforts by GM(HR/Admn) & DGM (Admn) to explain the facts. Shri AnilKumar Dubey behaved irresponsibly which is bad in law against the established principles of social norms. His utterances amounts to inflicting repeated insults & humiliation on women of our company. The Government of India has a major thrust in improving the living standards, social status of women and upholding their right to dignity. TWWO have chosen to stay away from BSNL Day Program forever and maintain a dignified silence from the cherished function of celebrations held on the occasion of Foundation Day of BSNL.

Instead of promoting women's , generating sense of self worth among our women, deed of said Shri AnilKumar Dubey is enormously unbecoming of responsible office of the company.

By aforesaid acts, Shri AnilKumar Dubey, had committed grave misconduct, failed to maintain absolute integrity, discipline and decorum of office and acted in a manner unbecoming of BSNL employee thereby contravening the provision contained in rule 4 (a), (c), (d) and (e) and rule 5 (10), (12), (20), (23), (25), (31) and (35) of BSNL CDA Rules 2006.
