**Subject:- Implementation of merger of Non-Territorial Circles and
Consolidation of Business Area**

With reference to the letter referred above, guidelines were issued for merger of Non-Territorial Circles and revision in consolidation of Business Area and rationalization of work flow process.

In accordance with the above order, competent authority has approved to merge following non territorial circles and Business area consolidation w.e.f. 01.10.2020. In order to implement the order, following actions shall be initiated and to be completed before 01.10.2020. A detailed guidelines on merger has already been issued by PGM(ERP), Ghaziabad and Sr. GM(CA), BSNL CO.

**1. Merger of Non-Territorial circles issued vide this office letter dated
14.01.2020 & 15.01.2020:-**

- (a) Merger of NTP & NTR, WTP & WTR shall be effective w.e.f. 01.10.2020
- (b) For merged entity, the orders of CGM-Core Network Tx (North) & CGM-Core Network Tx (West) shall be issued by Pers. cell before 01.10.2020. The merged circles shall make proposal on distribution of staff in accordance with the corporate office letter dated 14.01.2020 and shall submit the proposal to ERP and Personnel section. After distribution they shall also provide details of PGM/GM/DGM who will



be positioned at different locations in accordance with the approved structure and details (name & present place of posting of officers/executives) who are in excess and shall submit the details to Personnel cell corporate office by 28.09.2020. The Personnel Cell shall issue necessary orders in respect of the executives in the grade of PGM/Sr.GM/GM/DGM before 1.10.2020.

2. Business area Consolidation issued vide this office letter dated 27.08.2020 & 01.09.2020:-

- a) The Order shall be implemented in first Phase in AP, AS, HR, MH, OD, UP(W), WB circles and will be effective from 01.10.2020. Mean while some modification proposal has been received from few circles, apart from some operational issues raised by ERP team including FICCO, in implementing the order. These are under examination, which will take some time for decision by management. So, it has been decided to keep these SSA/BA merger on hold till a decision is taken by competent authority. The SSA/BA to be kept on hold are as under-
- Assam circle- Bongaigaon
 - Odisha- Dhenkanal, Keonjhar, Phulbani, Bhawanipatna
 - UP(W) circle- Ettah
- b) Posting orders in respect of GM level officers of these circles shall be issued by Pers. Cell in accordance with the structure issued vide order dated 27.08.2020 before 01.10.20.
- c) The implementation in respect of BA consolidation of remaining circles shall be effective from 01.11.2020.
