Sub: Regarding repatriating JAO's to MH Circle who were transferred under Rule-9 from Maharashtra Telecom Circle

With reference to the above cited subject and BSNL CO. letter reference regarding Amendment in Para 9 of BSNL Transfer Policy, it is intimated that many JAO's of 2010/2015 batch were temporarily transferred under Rule-9 for 1 year from Maharashtra Telecom Circle to other circles (79 JAO's list is enclosed at Annexure-I) by BSNL CO, New Delhi. The parent circle of transferred officials under Rule-9 is Maharashtra.

After VRS-2019 there is acute shortage in Accounts cadre. Maharashtra Telecom Circle is the largest revenue contributing circle. Also, many JAO's have applied for Rule-8 transfer on completion of 5 years' service & Rule-9 transfer on completion of 2 years' service. Many JAO's Rule-8 transfer application is approved and concurrence from respective circles have been received to MH Circle (List enclosed at Annexure-II)

It is difficult to relieve the JAO's under Rule-8 due to shortage of accounts personnel.

As there is shortage of accounts personnel in MH Circle, it is kindly requested to issue necessary instructions to the concerned circle's for repatriated/transferred JAO's as per Annexure-I back to MH circle at the earliest.
