Sub: Repatriation of BSNL Staff, working in DoT and its field units.


The undersigned is directed to state that the matter regarding repatriation of BSNL Staff, working in DoT and its field units was referred to DoT. In this regard DoT vide its OM No. 1-50(18)/2019-Estt (Copy enclosed) has clarified that:

- a) Vide OM No. 1-50(22)/2015-Estt dated 25.05.2018, DoT field units were allowed to treat BSNL/MTNL staff working/retained in the DoT field units on deputation basis for a period of 3 years as one time measure w.e.f. 01.04.2018 or till the posts are filled on regular basis as per RR whichever is earlier.
- b) Some officials of BSNL/MTNL, working in DoT were on internal ad-hoc arrangement between BSNL & DoT to meet the immediate requirement of DoT field units. As per DoT OM No. 1-50(22)/2015-Estt dated 25.05.2018, which was issued with the approval of the then MoC, formal deputation term as provided vide DoP&T OM 2/6/2016-Estt. (Pay-II) dated 17.02.2016, in respect of above BSNL employees started with effect from 01.04.2018.
- c) Therefore, the condition of maximum tenure of 5 years deputation at a stretch extendable up to a period not exceeding 7 years has not been violated in this case.

In view of above, concerned circles may act accordingly while dealing with matters related to repatriation of BSNL staff working in DoT and its field units.

This issues with the approval of Competent Authority.

The undersigned is directed to invite your kind attention towards DoT OM No. 1-50(22)/2015-Estt dated 25.05.2018 vide which DoT field units were allowed to treat BSNL/MTNL staff working/retained in the DoT field units on deputation basis for a period of 3 years- as one time measure w.e.f.01.04.2018 or till the posts are filled on regular basis as per RRs, whichever is earlier.

2. In this regard, it may be noted that some officials of BSNL/MTNL, working in DoT were on internal ad-hoc arrangement between BSNL & DOT to meet the immediate requirement of DoT field units. As per DoT OM No. 1-50(22)/2015-Estt dated 25.05.2018, which was issued with the approval of the then MoSC, formal deputation term as provided vide DoP&T OM 2/6/2016-Estt.(Pay-II) dated 17-02-2016, in respect of above BSNL employees started with effect from 01.04.2018, Therefore, the condition of maximum tenure of 5 years deputation at a stretch extendable up to a period not exceeding 7 years has not been violated in this case.
