Sub: Review of the facts of Present District Body of Circle Office Mumbai.

Ref: Your Office letter No. CGMT MH/Admn-I/SNEA (I)/2018-2019/Part File/29 Dated 29/09/2018.

R/Sir,

With reference to above, subject and concern raised by you about the period of District Body it is fact that the period of District Body is of two years and Election of New set of office Bearers of SNEA Circle Office Mumbai is due. But this matter is well aware to Circle administration and we have discussed this matter with GM HR Admn Mumbai that as District Quota is not received by all the branches of SNEA Maharashtra including Circle Office Mumbai and hence District Conference to elect new office Bearers are not being hold.

Further, the allegation made by your good self that this is clear violation of the provisions of our Constitution is not true, as we have no intention to violate the constitution as we fully respect to the constitution of SNEA and there should not be any doubt on part of anyone. But for holding District Conference, we cannot meet the provisions under unavoidable circumstances due to non-availability of District Quota, which is basic principle of the constitution of SNEA to run the day-to-day activities of association.

Your good self may be aware that as per constitution, any General Body Meeting or conference of any association is arranged from the subscription paid by the members. Earlier we use to collect subscription from members and after membership verification conducted by BSNL the facility of deduction of subscription from monthly salary of the members of SNEA has been started w.e.f. Jan 2017 and monthly subscription of all members all over India is being centrally deducted and handed over to Treasurer SNEA CHQ, who in turn has to handover Circle & District Quota to Circle Treasurer who in turn has to handover District Quota to District Treasurer.

But due to delay in reconciling the data and amount received from different SSAs throughout India and also due to receipt of partial amount in different months by CHQ Treasurer from different SSAs/Circles/units, CHQ has not yet transferred even single rupee to SNEA Maharashtra Circle and no question of receipt of even single rupee by SNEA Mumbai. Rather we the office Bearers of SNEA Mumbai are making some minimum required expenses for day to day functioning of SNEA Mumbai from our own pockets. Apart from this, as CS SNEA MH is in Mumbai and there is no fund available with Circle for last one year and we the office Bearers of SNEA Mumbai contribute for Circle expenses on part of SNEA MH. As no funds are available with SNEA Mumbai, we were not in position to hold the District Conference Mumbai as certain expenditure is required in arrangements of Conference.

These facts have been brought to the notice of CS SNEA Maharashtra and hence CS SNEA MH has extended period of District Body of SNEA Mumbai till conduction of elections. Accordingly letter have been issued to GM HR Admn Mumbai intimating validity of the District Body vide letter No. SNEA MH/Cir Corr/ 2017-19/28 dated 08/05/2018 and No. SNEA MH/Cir Corr/ 2017-19/28 dated 22/06/2018 for grant of immunity till Dec 2019 and same has been accepted by GM HR Admn Mumbai & approved by CGMT MH and immunity has been granted to Com. S R Potul DT SNEA Mumbai and me as DS SNEA Mumbai. It would have been better on your part that you would have confirmed facts from Staff section before writing such letter to us wherein time and energy of administration would have been saved in writing such unwanted and untimely letter. We are surprised to your letter asking to review the matter, which is well aware to your kind office.

Further CS SNEA MH has requested to GS SNEA CHQ to pass on District Quota of all branches including facts of delay in holding District Conferences by many of the District for non-availability of funds. After persuasion for long time finally, Treasurer SNEA CHQ has intimated certain amount will be transferred to SNEA MH in first week of October 2018 and very shortly entire amount due as per calculations will be handed over to SNEA MH. Further CS SNEA MH has informed that that SNEA MH will hand over the amount of District Quota from Jan 2017 to till today i.e. for period of 21 months will be handed over to all SNEA Districts in Maharashtra Circle in proposed CEC meeting of SNEA MH, which is scheduled, on 13th & 14th October 2018 at Jalgaon.

Accordingly , and SNEA Mumbai has already planned District Conference to elect new set of office Bearers it in last week of October 2018 or in first week of November 2018 as per availability of Conference hall, suitability of date for presence of maximum members of SNEA Mumbai and availability of prominent Circle leaders to attend this District Conference. We have already kept notice of District Conference ready (Copy attached) and after receipts of District Quota, the date will be finalized in consultation with all and conference will be before second week of November 2018.

But if it is felt by management or as concerned expressed by your good self that SNEA Mumbai should hold the District Conference before above proposed dates, we are ready to hold it at any date except from 11th October 2018 to 14th October 2018 during which SNEA leaders will be engaged in CEC Meeting at Jalgaon. But for any such meeting as will be decided by your good self before last week of October 2018, we only need support from your Good self as part of the management to direct Caterer of the BSNL Canteen Mumbai to make arrangements of the food for District Conference of SNEA Mumbai on loan basis and I assure that on immediately on receipt of District Quota, SNEA Mumbai will hand over the dues to the Caterer of the Canteen.

Also as per the constitution of SNEA clause no. 11 (a) (iv) , we will have to issue 15 days' notice for holding District Conference and formal notice for holding District conference SNEA Mumbai will be issued by next week after confirmation of receipt of District Quota from SNEA CHQ. We further assure that even if District Quota is not received for any reason, the District Conference of SNEA Mumbai to elect new office Bearers will be held in last week of October 2018, or maximum first week of November 2018 by collecting willing donations from members by appeal to them. As concerned is raised by your good self for holding District Conference, we will not wait further for receipt of District Quota and proceedings of District Conference of SNEA Mumbai will be completed in time bound manner.

Hope all above details will be agreeable to your good self and we will be clearly directed where holding of District Conference in Last week of Oct 2018 or in first week of Nov 2018 is acceptable to your good self or we will have to hold emergency District Conference without following clause of SNEA constitution giving 15 days' notice for holding District Conference and permit us to hold the District Conference with notice of just 2-3 days as will be decided by your good self and complete official formality of election of new office Bearers for SNEA Mumbai.

We will be waiting for clear directions for holding the District Conference of SNEA Mumbai so that immediate action can be taken by SNEA Mumbai as decided by administration.
