Subject: Consolidated tariff after revision of landline & Broadband plans provided by BSNL to Hon'ble MPs (Lok Sabha & Rajya Sabha).

- 1. Kind reference is invited to this office letter No.1-1/2009-R&C(CFA) [Circular R&C No.39/2010-11] dated 03.11.2010 vide which the Broadband plans exclusively for the Hon'ble Members of Parliament of Lok Sabha and Rajya Sabha were introduced and these plans were revised on 27.11.2018 for Hon'ble MPs (LS & RS) on revised Broadband speed on Copper ADSL+ with voice calling facility separately.
- 2. Further, a consolidated tariff for Landline & Broadband to Hon'ble MPs (LS & RS) were issued vide letter No. R&C-CFA No. 23/12-13 dated 14.09.2012, where FMCs of Broadband & Landline were as below:
 - (a) FMC for 1st BB plan BBMP ULD 1500 was kept Rs. 1500/- per month.
 - (b) FMC for 2nd BB plan BBMP ULD 1000 was kept Rs. 833/- per month.
 - (c) FMC for Landline plan LLMP1India was kept Rs. 180/- per month.
- 3. These Broadband plans i.e. BBMP ULD 1500 & BBMP ULD 1000 were further allowed over FTTH network, if BB not feasible on Copper (ADSL+ network), but feasible on FTTH vide letter No. 2-4/2009- PHA(Pt.) dated 01.06.2016.
- 4. Again these Broadband plans were revised vide letter No. 1-1/2020-R&C[CFA] dated 27.07.2020 & 11.08.2020 (Circular R&C-CFA No.28/20-21) and their nomenclatures were also changed with speed & data usage limit. But the FMC of 2nd Broadband plan BBMP ULD 1000/BB SANSAD ULD 1000 was mentioned as Rs. 1000/- per month in existing plan column inadvertently.
- 5. Consolidated / revised tariff plans for landline & Broadband as per approval of competent authority are as below:-
