It is further mention that UIDAI may add/withdraw Aadhaar services time to time and rate of assistance to registrar & maximum fee that can be charged from residents by Registrar for Aadhaar services at OCSCs.

In view of above, competent authority has decided that the amount (incl. GST) for Aadhaar services at OCSC by OCSC Partners for both assistance from UIDAI & Fee collected from Residents by registrar shall be shared between BSNL and OCSC Partner(s) as: -

(i) for an amount above Rs 50.00 in 50:50 proportion,

(ii) for an amount upto Rs 50.00 in 60:40 proportion.

  - c) Operator/Supervisor: Employee/contract employee on roll of the Registrar/EA or hired from a manpower hiring agency on salary basis.
- 2. In case of Registrar following the Village Level Entrepreneur (VLE) model, wherein VLE brings his own kit and works under Registrar/EA, the Registrar shall be given rate of assistance as given in Table-2.
