Sub: Delay in relieving the executives / officers under transfer to other circles / units in BSNL- Direct relieving by Corporate Office-regarding

1. Pursuant to this office instructions conveyed vide this office letters of even number 400-11/2011-Pers.I(Pt) dtd 14.07.2017 & 10.08.2017, wherein it was emphasized that the transfer orders issued by Corporate Office but pending for implementation despite repeated directions shall be executed by way of relieving of such executives under transfer for / from tenure circles directly by Corporate Office itself in the interest of service.
2. Accordingly, the following executives in the grade of SDE of Telecom Operation stream stand relieved by Corporate Office on **02.11.2018(A/N)** through ERP. The officers shall join their assigned place of posting immediately. The claims of transfer related benefits etc. shall be entertained by the reporting Circle on joining.

4. Charge reports may be furnished to all concerned. Joining & relieving entries may be made in HRMS/ERP/service Book.
5. Any change/modification noticed in the transfer orders as given in detail may be referred to BSNL CO immediately.
6. Posting of executive to the sensitive / non-sensitive post may be decided by the concerned circle as per prescribed norms circulated by DOT & Vigilance Branch of BSNL Corporate Office from time to time.
