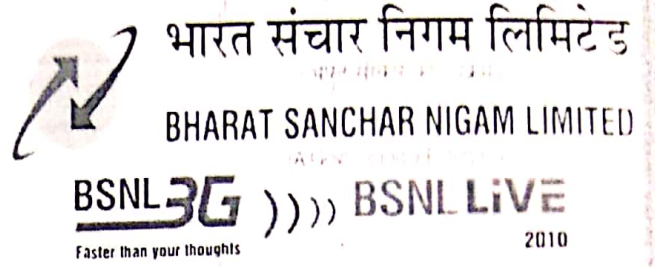

5.0 The leave if any, requested by the executives under transfer, shall not be granted by the controlling officer where he is presently working.

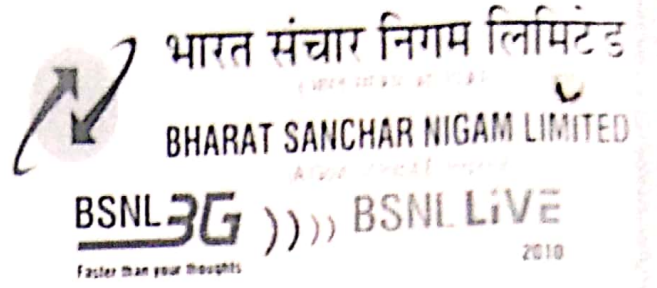
6.0 The service in higher grade under this arrangement will not count for any benefit in matter of future promotions, seniority.


