Vide letter under ref ,wherein it was requested to all SSA of MH. Circle to float the SLA based Tender of OFC Mntc for their SSAs as per revised draft tender document for 2020-21.This contract was applicable for period.of ONE Year from the dated of issuing the first work order.In this respect following is mentioned :

1. SLA based OFC Mtce Tender to be floated 3 to 4 months before of expiring the existing contract period .So that tenders/contracts are finalized & operative after expiring of existing contract.
2. If due to any reason SLA tender not finalized before completion of contract period & extension of existing arrangement / contract is required then in such cases , contractor has to carry out 1% O/H to U/G work propotionately for extended period also.
3. Vide letter under ref(2) & Guidelines issued by BSNL C.O. for formation of In-house FRT for maintenance of Urban OFC Network by FRT comprising the one JE/JTO, One Splicer, One Vehicle and 2 to 3 outsourced manpower on job work basis.It is observed that some SSAs have not formed in -house FRTs or have allocated lesser RKM to in-house FRTs than proposed by Circle Office.All Such SSAs are once again requested to form in house FRTs and maintain the RKM as proposed by Circle office.
4. Vide letter under ref(3) ,it is intimated that in SSAs where frequency of fault/day/month is very less/Nil in some routes, it is suggested that same may be analyzed by SSAs, and such routes be got maintained by in-house FRTS only instead of being outsourced through SLA based contract. This shall result in avoidance of unnecessary expenditure and is the need of the hour considering the financial crunch in BSNL.
