

Sub: Issues taken by MH Circle for promoting TiPs Revenue share Model -reg

Ref: letter No. CGMT/MH/S&M-CFA/FTTH-EOI/Vol-II/2019-20/020 dated June 06, 2019,

- 1. Kindly refer above mentioned letter wherein CGM Maharashtra Circle has requested for the few promotional approvals for TIP/Digital Gram Sevak Revenue Share model.
- 2. In this regards, case examined at BSNL Co and it has decided as follows:

î.	Incentives to TIP for Bill collections through FTTH wallet/BSNL E-pay similar to CBPCT as per No 2-21/2018/BSNL/RM-I/CFA/CBPCT dated 12.12.2018	The maximum ceiling of revenue share for TIPs have already been defined as per the business model for which TIP has done the agreement for bill collection. Circle can educate the additional services like e-pay for facilitating early collection of bills through online methods.
ii.	Allowing TIPs to use BSNL premises /CSCs for sale and services activities similar to permission given to BSNL channel partners vide Ltr no 19-2/2013-S& M -CM dated 31.07.2013	A decision can be taken at circle level based on the circumstances related to management of CSC, requirement of BSNL for other sales and promotion activities.
iii.	Special fund request for TIPs Monthly Revenue share payments pending from Dec-2018.	Instructions has already been issued to ITPC for release of 50% pending payments in form of FTTH wallet balance
iv.	Waiver of infrastructure charges (up to 30.06.2019) for installation of OLTs in BSNL Premises for channel partners.	Powers have already been delegated to the CGMs for waiver of infrastructure charges based on the business done by channe partners.

-	V	Extend the facility of wallet TOP UP by online methods viz. Net banking /RTGS etc to TIPs.	to AO(Cash) of the SSA, who can in turn de the wallet recharge for the FTIM partners.
	vi.	Facility of cheque/NEFT payments to be added for BSNL E-pay at the earliest.	Customers can do payments through e-pay system using net banking and other related methods which are same as NEFT.
-	vii.	Diversion of 25% revenue share payments due for May 2019 as FTTH wallet TOP UP	Instructions has already been issued to ITPC for release of 50% pending payments in form of FTTH wallet balance

- 3. We appreciate the efforts made by MH Circle in FTTH Business. Corporate office shall provide all support to Maharashtra Circle to further increase the FTTH Business.
- 4. Further, it is also intimated that preferred to FTTH franchisee shift on prepaid wallet for receiving real time revenue share., it is observed that initially a Wallet recharge of Rs.10,000/- Channel partner can earn revenue share of more than Rs.7000/- as per annexure through bill collections.
