
- (i) To bring greater awareness on complaints under Public Interest disclosure and protection of Informers (PIDPI).

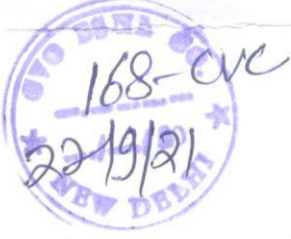
