Sub:- Calling options for posting at tenure stations for the period upto September 2019 in the grade of JTO/SDE/DE/DGMs - regarding.

This office is going to issue tenure transfer orders in r/o officers in the grade of JTO/SDE/DE/DGMs working at tenure stations in Maharashtra Circle and who are going to complete their SSA tenure of two years/All India Soft tenure of 3 years (Only for declared station at Sindhudurg and Gadchiroli) by 30th September,2019. In addition to this, the shortage of executives has been noticed by this office in various grades in these tenure SSAs. In this connection options are hereby called amongst JTO/SDE/DE/DGMs for posting at tenure stations (**Dhule, Gadchiroli, Goa, Raigad, Ratnagiri and Sindhudurg**) in Maharashtra Circle.

If sufficient numbers of options are not received, the transfer posting shall be done according to stay particulars, in the respective cadre as per extant orders and guidelines considering administrative requirement/needs.
