
ORDER

Persuant to BSNL MH Circle office Recruitment Branch letter No. MHCO-RECT/14(11)/1/2022-HR-ADMIN Dated 02.09.2022, the Competent Authority in B.S.N.L. is pleased to promote and post the officials from JE(T) to JTO(T) grade after successful completion of 10 weeks of Phase-I training and followed by 4 weeks of field training, against vacancies for the year 2021 (50% internal quota) under Limited Internal Competitive Examination(LICE) as per the details contained in the Annexure (enclosed) from the date they assume charge of the higher post provided that:-

- 6. The leave, if any requested by the official, who has been posted on promotion to different BA/OAs, should not be allowed.
