ORDER

Sub: Promotion and posting of JEs to the grade of JTO(Telecom) under LICE held on 07.08.2022-Reg.

Persuant to BSNL MH Circle office Recruitment Branch letter No. MHCO-RECT/14(11)/1/2022-HR-ADMIN Dated 02.09.2022, the Competent Authority in B.S.N.L. is pleased to promote and post the officials from JE(T) to JTO(T) grade after successful completion of 10 weeks of Phase-I training and followed by 4 weeks of field training, against vacancies for the year 2021 (50% internal quota) under Limited Internal Competitive Examination(LICE) as per the details contained in the Annexure (enclosed) from the date they assume charge of the higher post provided that :-

- I. they have been absorbed in B.S.N.L. on permanent basis;
 - II. no disciplinary/vigilance case is pending against him/her and no VC is withheld in terms of instructions issued bt D.G.P&T/DoP&T from time to time.
 - III. the currency of any penalty against the official is over; or
 - IV. The official has not retired on the date of issue of the order.
 - V. They have fulfilled the prescribed eligibility criteria of regular service as per Recruitment Rules(RR) mentioned in the Examination Notification dated 21.04.2022
2. This office will decide such cases as detailed in Para 1 supra on receipt of information from concerned BAs. Information in this regard may be brought to the notice of this office immediately and the concerned official should not be promoted or relieved for posting without specific orders from this office.
 3. All BAs concerned may please ensure that the promotion/posting orders in respect of officials found eligible after fulfilling the above conditions are issued in time to enable the officers to join their promotional assignment, and the official is relieved with immediate effect after completion of field training.
 4. In case the official concerned fails to join the promotional assignments within the prescribed period, he/she should not be allowed to be relieved or join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action.
 5. BAs concerned are further directed that the pending request of the official for modification of the promotion/posting order cannot be taken as ground for non-relieving which leads to non implementation of the promotion order in respect of the officials.

6. The leave, if any requested by the official, who has been posted on promotion to different BA/OAs, should not be allowed. If any official desires leave, he/she can apply for leave to new Head of BA/OA under whom he/she has been posted only after joining the new post and new BA/OA Head will sanction leave, if it is considered justified in normal course.
7. The date on which the above order is given effect to may be intimated to this office, and accordingly, a consolidated report of the officials who have been relieved/have joined their new postings may also be sent to this office to assess relieving and joining status of the promoted officials. Charge reports need not be endorsed.
8. The seniority of the official promoted under this order shall be determined in accordance with the rules in force and will be issued separately.
9. The aforesaid promotion order is subject to the final outcome /decision in any lawsuit(s) pending before any court(s) etc., including cases mentioned in Examination Notification dated 22.04.2022.
10. The particulars of officials may also please be updated by Concerned BA Admin in ERP/service Book as soon as they are relieved/ join as JTO(T) on the basis of this order.
11. Pay fixation on promotion be done as per prescribed norms
12. BAs concerned may ensure that the requirement of malpower against New Projects/assignments may be fulfilled from these Officers posted to their BA/OAs.
